

- The Suppliers must be the manufacturer or the authorized agent/ dealer / representative of the manufacturer. In case of manufacturers they have to submit the manufacturers form along with tender as per the format enclosed (Format-I). In the case of dealer/ distributor/ agent/ representative, certified valid copy of the authorization issued by the manufacturer (Format-II) should be enclosed with the tender.

- The tenderer must submit **Earnest Money Deposit (EMD)** for Rs.5000/- In form of Bank draft drawn in favour of **"The Principal, Binayak Acharya College"**, payable at Berhampur.
- **Non refundable tender fee of Rs.500/- in form of demand draft in favour of "The Principal, Binayak Acharya College"** and Payable at Berhampur.
- The EMD of the unsuccessful tenderers will be returned to the concerned tenderer immediately after finalization of the tenders.
- The EMD of the successful tenderer will be refunded after completion of the supply and installation of the CCTV Cameras and other appliance to the satisfaction of the concerned authority of Binayak Acharya College.
- The quoted rates shall include the bidders cost towards insurance, packing and forwarding and transportation at Binayak Acharya College, Berhampur.
- The quotation should reach the undersigned by **12-01-2019 at 05:00P.M.** through Registered Post/ Speed Post or by hand in the office hour. Quotations received after the due date will not be considered / entertained.
- The successful tenderer should supply the items and install the CCTV Cameras within a period 01 week from the issuing date of purchase order.
- The suppliers should enclose Xerox copies of all required documents i.e. GST Certificate, I.T. / PAN certificate / Annual Turn Over Certificate (at least 3 years) etc.
- Price of items & Tax components should be mentioned separately.
- No transportation or other charges, if any, will be entertained.
- The firm should furnish an undertaking for regular maintenance during the warranty periods.
- A warranty certificate covering a period of minimum two year from the date of installation shall be provided. Any additional period towards warranty will be given weightage in evaluation of the quotations.
- During the warranty period or later whenever the firm is called upon to attend to the rectification of the defects / faults in the instruments, the firm shall attend to the repair of instrument within 48-96 hours. They should render timely back up service whenever called upon. **A undertaking to the effect should be submitted by the firm.**
- The firm / Authorized dealer may suitably have a branch / Local Office at or near Berhampur City.
- **The invoices should be submitted in triplicate** in the name of **"The Principal, Binayak Acharya College, Berhampur"** for pass and payment. The payments will be made only after successful installation of supplied items.
- **If any clause(s) is (are) missed in this bid document the guidelines of procurement of goods vide Memorandum no.4939/F/Codes-27/2011, Dated.13-02-2012 of Finance Department, Govt. of Odisha will be followed.**
