**NOTIFICATION**

Bhubaneswar dated the <sup>10th</sup> October 2023

No. Acd /12/16(Pt)/ 5682 / CHSE . In continuation to Notification No. 3375 dt. 05.08.2023 the following guidelines are issued for students, teachers and all others concerned of Higher Secondary Schools affiliated to CHSE(O).

**Syllabus for XI students (2023 admission batch):**

1. **Arts Stream:** Syllabi of all subjects in Arts stream which were recommended for the students of 2016 Admission batch (AB) and continuing till date shall be applicable for students of 2023 admission batch, and these are available in CHSE website [www.chseodisha.nic.in](http://www.chseodisha.nic.in).
2. **Commerce Stream :** Syllabi of all subjects in Commerce stream which were recommended for the students of 2016 Admission batch (AB) and continuing till date shall be applicable for students of 2023 admission batch, and these are available in CHSE website [www.chseodisha.nic.in](http://www.chseodisha.nic.in).
3. **Science Stream :** Syllabi for all subjects in Science stream which were recommended for students of 2016 Admission batch (AB) and continuing till date shall be applicable for students of 2023 admission batch **except for the subjects Physics, Chemistry, Mathematics and Biology**. The rationalized syllabi in Physics, Chemistry, Mathematics and Biology shall be applicable for students admitted in 2023-24 session. 4. **Vocational Stream :**
  - a) Syllabi in compulsory subjects of Vocational stream i.e. English and M.I.L.(Odia, Alternative English, Urdu, Telgu, Sanskrit and Bengali) which were recommended for students of 2015 Admission batch (AB) and continuing till date shall be applicable for students of 2023 admission batch syllabi in all the above compulsory subjects are available in the CHSE website [www.chseodisha.nic.in](http://www.chseodisha.nic.in)
  - b) Syllabi for BFC subjects in Arts and Commerce of Vocational stream which were recommended for students of 2015 Admission batch (AB) and continuing till date shall be applicable for students of 2023 admission batch Syllabi in all the above BFC Subjects are available in the CHSE website [www.chseodisha.nic.in](http://www.chseodisha.nic.in)

- c) BFC syllabi for Physics, Chemistry, Biology and Mathematics of Vocational Stream shall be the rationalized syllabi that are recommended for science stream and notified vide Notice No. 3900 dt. 28.07.2023. Syllabi for all the above BFC subjects of Vocational Stream (Science) are available in the CHSE website [www.chseodisha.nic.in](http://www.chseodisha.nic.in)
- d) Syllabi for all trade papers of Vocational stream which were recommended for students of 2016 Admission batch (AB) and are continuing till date shall be applicable for students of 2023 admission batch. The Syllabi for all trade papers are available in the website [www.chseodisha.nic.in](http://www.chseodisha.nic.in)
- e) Further **SEVEN** new job roles have been introduced from 2023 admission batch. The newly introduced job roles are -
- Electronic Hardware( Field Technician-Air-Conditioning),
  - IT-ITeS (CRM Domestic Voice),
  - BFSI (Business Correspondent/ Facilitator),
  - Agriculture (Dairy Farmer/Entrepreneur)
  - Agriculture (Small Poultry Farmer)
  - Sport, Physical Education, Fitness & Leisure (Primary years Physical Activity Facilitator)
  - Tourism& Hospitality (Counter Sale Executive)

**5. Examination pattern for class-XI(2023 admission batch):**

**There shall be both Internal Assessments and Annual Examination as described below:**

**I. Internal Assessment:**

The Higher Secondary schools will conduct two Internal Tests for the Class XI students of Arts, Science, Commerce & Vocational stream at their level. The subject teachers will set question papers as per CHSE pattern and evaluate the answer script. Entire cost of examination will be borne by the H.S.School and there will be no remuneration for the conduct of these examinations and evaluation.

- **Question papers and evaluation for Internal and Annual examination:**

The question papers shall be set by the teachers concerned of respective Higher Secondary Schools. Evaluation of the answer scripts are to be made by the subject teachers of the Higher Secondary school concerned.

- **Tabulation and result publication:**

All marks are to be tabulated in tabulation register in scientific manner. The page numbers and other details of the TR are to be certified by the Principal of the HS School concerned in the first page of the TR. Entries of TR must be made by the tabulator only and he or she has to put his/her signature on every page of TR.

**There is no pass or fail in internal tests.**

- **Results(in Annual Examination) are to be declared as per CHSE rule.** One has to secure minimum 30% in each theory and 40% marks in each of practical paper, and

an aggregate of 35% of total marks, i.e. one has to secure 210 marks out of full marks 600 and has to pass in every paper individually.

**One has to pass in Annual Examination of Class XI to be eligible for readmission into class XII.**

• **Uploading of Internal Test marks**

The marks obtained by the students in Internal Tests will be uploaded by the institutions in CHSE portal during the period which will be intimated in due course of time.


