## NOTIFICATION


The Vice-Chancellor, Berhampur University, by virtue of powers vested on her under Section 6 (15) of the Odisha Universities Act, 1989 has been pleased to approve the following regulations as recommended by the Regulation Committee in its meeting held on 20.11.2024:

1. The Model Regulation for Under Graduate Programmes with Multiple Entry and Exit Option prepared by the ODISHA STATE HIGHER EDUCATION COUNCIL be adopted with minor modification in Clause 21.4 as follows:

*Scanned copy of answer scripts shall be provided to the applicants (self) with a fee of Rs. 500/- (Rupees five hundred only) per answer script to be deposited through SB Collect in favour of Comptroller of Finance, Berhampur University. The scanned answer scripts shall be sent to the applicants through his/her Email Id. This fee is also applicable to those who apply for answer scripts under RTI Act. Candidates should apply in the prescribed Proforma available in the University Website.*

2. As per the Proceedings of the Meeting held on 21.09.2024 Clause No.1 communicated vide Letter No. 1435/187/OSHEC(Part-II) dated 23.10.2024 of ODISHA STATE HIGHER EDUCATION COUNCIL it is decided that those who secure 50% in aggregate of Core (I/II/III), AEC, MDC, SEC and VAC shall be awarded with Distinction. Malpractice/Hard Case/Repeat/Failed/Improvement/Back appeared candidate shall be excluded.
3. The eligibility criteria to be a Research Supervisor for guiding scholars shall be considered only after completion of two years from the date of award of Ph.D. of concerned teacher and publication of at least two research articles after award of Ph.D. Degree. This shall be over and above the other eligibility criteria fixed earlier.
4. The fee of Rs. 500/- (Rupees five hundred only) fixed for providing one answer script under RTI as at Sl. No. 1 above shall be applicable for all Examinations conducted by the university (UG, PG, Professional, etc.). Similarly, the answer scripts (scanned copy) shall be sent through email only and within the timeline prescribed in Clause 21 of Model Regulations, i.e., 45 (Forty Five) days from the date of publication of the results.
